 - She would provide food/drinks since not charging
 - Could be good exposure for the club
 - Maybe designate one thing a year like this as will probably get additional requests
 - Potential news coverage; maybe just one newspaper and one tv news crew
 - Maybe in fall once races are done and cooler weather
 - Need a commitment for volunteers to do it
