President Aaron G was unable to attend the meeting. Vice President Zachary B ran the meeting in his absence.

Mandy discussed preparations for FONDO:

- Rudy's will provide food
- An Emcee has been arranged
- Central Illinois Mountain Bike Association (CIMBA) will provide SWAG for the raffle
- Some SWAG has been received, but more is needed. Options are to contact businesses outside
 of bike shops, such as breweries, and to consider purchasing items from LBS at cost and raffling
 those items.
- We need a good supply of firewood for the Crotch area and the Lodge area. Andy pointed out
 he's got a nice supply of old rough cut at Sunderbruch. This will be difficult to remove after the
 impending snowmageddon, so other sources will be required. There is some firewood available
 on Credit Island but moving it may prove difficult. During the Membership meeting Jeremiah C
 generously offered to donate a supply of good firewood. The Board will provide a donation
 letter so he may deduct the value from his taxes.
- Mandy is looking for help manufacturing trophies. She brought a flyer with some ideas. Brad,
 Dave and Andy have access to power tools to manufacture the wooden bases for the trophies;
 Mandy will hit up the LBS for scrap rotors, etc. to be used to finish them.

Regarding other events, Mandy noted the permit for the Stampede in April has been approved. She has not heard back regarding the permit for the Illiniwek Abermination in May.

The Board was unable to agree on a cool name for the upcoming Membership Party, which will feature a "smoke-off" contest to encourage folks to bring their best smoked meats. The Board agreed to purchase HyVee gift cards with values of \$100, \$50 and \$25 to use as prizes for the smoke-off. The membership party will be held from 6:00 p.m. to 10:00 p.m. on February 23rd at Icons Martini Lounge in Rock Island. FORC will provide side dishes; the Board set the budget for the entire event (including the prize money) at \$500.

The annual Swap Meet is set for March 10th at the Village Theatre in Davenport, between 11:00 a.m. and 1:00 p.m. Those who wish to purchase a table for this event should contact Mandy.

Glen provided the Treasurer's Report:

The Group has \$31,035 in the bank after paying for insurance and other expenses approved at the December meeting. Glen reported the additional liability insurance the Board approved for Officers and Board members will cost about \$400 and there is additional documentation to be submitted as part of the application. Glen will continue this effort as he has time. As noted last month, the insurance for our four races will come to \$1260.

Glen noted we received a donation of \$150 from the Trail Sisters, a local running group.

Glen also noted in his report if we pay separate insurance for our four scheduled events in 2024 that will be about \$1260.

There was a brief discussion about using Birdies for Charity to raise money. Following discussion the Board decided to NOT pursue this option.
